At 7:51 p.m. motion made by Arensdorf, seconded by Harrel the City Commission recess into executive session with the City Manager, the City Attorney, and Attorney Matt Ricke for consultation with the City Attorney regarding a matter which would be deemed privileged in the attorney-client relationship pursuant to the attorney-client privilege exception in K.S.A. 75-4319(b)(2). The open meeting will resume in the city commission chambers in 10 minutes. Motion declared carried by unanimous vote.

At 8:01 p.m. the meeting reconvened.

Motion made by Arensdorf, seconded by Wollen appoint Matt Ricke as City Attorney for the estate of Russell Williams. Motion declared carried by unanimous vote.

ADMINISTRATION REPORT: There were 25 disconnections this month. We were awarded \$82,722.50 for the downtown sidewalk project. The Christmas banners are in. We have the water emergency this past week. If you see Dale and his crew, thank them for rectifying the problem so quickly. Pool Report for June is in. Waste Connections will increase rates 2% in September. The Fair Board would like to know if the Commission would waive the rental fees during the fair for the arena.

Motion made by Hacker, seconded by Arensdorf waive the rental fees for the Fair Board when using the arena during the fair. Motion declare carried by unanimous vote.

COMMISSION COMMENTS: Hours and Locations for fireworks need to be posted. Limb pile is open. Dixon and Benson are not city streets. Department Heads need to plan who they will have to replace them when they retire. Thanked City for replacing Christmas decorations. City signs need to be mowed around and lights need to be placed at the signs.
