**CALL TO ORDER:** Mayor Wollen called the meeting to order at 7:00 p.m. on Tuesday, December 22, 2020 at the City Commission Room at City Hall via ZOOM. Commissioners Harrel, McFarland, Hacker and Arensdorf were present. Also present were Manager Graffman, Attorney Smith, Chief Lux and Clerk Conrardy.

**AGENDA:** Motion made by McFarland, seconded by Harrel approve the agenda. Motion declared carried by unanimous vote.

**MINUTES:** Motion made by Arensdorf, seconded by Harrel approve the minutes of the December 10<sup>th</sup> Commission meeting. Motion declared carried by unanimous vote.

**BILLS PAYABLE:** Motion made by Hacker, seconded by Arensdorf approve the bills payable in the amount of \$487,386.14. Motion declared carried by unanimous vote.

**HEARING:** Mayor Wollen opened the budget hearing for comments. There being no written or oral comments motion made by McFarland, seconded by Harrel close the hearing. Motion declared carried by unanimous vote.

Motion made by Hacker, seconded by McFarland adopt the amended budget. Motion declared carried by unanimous vote.

**ECONOMIC DEVELOPMENT DIRECTOR:** Leslie Schrag submitted the last report to the County for SPARK Funding. January 6 should be the last payment. Leslie updated the Commission on the CDBG Project, Façade program, which Cunningham and Norwich are both on board, Think Kingman program, signs & flyers and also had a spec sheet for the Koch Building.

**KINGMAN KUDO AWARD:** Vice-Mayor Harrel presented this month's Kudo's Award to Bobz Bikz, which Debbie Massey was present to accept the award. Bobz Bikz does a tremendous amount of business out of their shop.

**RUNWAY CHANGE ORDER:** Motion made by Hacker, seconded by Arensdorf accept change order #1 which decreased our contract with JLT Contracting by \$32,888.05. Motion declared carried by unanimous vote.

**SCKEDD CONTRACT:** Motion made by Arensdorf, seconded by Harrel approve the contract with SKEDD to provide grant writing services for the Moderate-Income Housing for the City of Kingman. Motion declared carried by unanimous vote.

**SPARK MEMORANDUM OF AGREEMENT:** Motion made by Hacker, seconded by Arensdorf adopt the Seconded Amendment to Memorandum of Agreement with the County. Motion declared carried by unanimous vote.

**CMB:** Motion made by McFarland, seconded by Arensdorf approve the cereal malt beverage license for Houdini's Pizza subject to clarification of information. Motion declared carried by unanimous vote.

Motion made by Harrel, seconded by Arensdorf approve the cereal malt beverage license for Polished Coupe subject to clarification of information. Motion declared carried by unanimous vote.
