WALKER PARK AG LEASE: Motion made by Hacker, seconded by Arensdorf allow Ryan Kinsler to farm the Walker Park location this year. Motion declared carried by unanimous vote.

ADMISTRATION REPORT: The Aquatic Park Task force is having a fund-raising event at the Country Club on Wednesday. For Public Power Week, October 4 through 8, the city will have a food drive and will donate to the Food Bank. Copeland Street is looking nice.
