**CALL TO ORDER:** Mayor Harrel called the meeting to order on Thursday, August 11, 2022, at 7:00 p.m. at the City of Kingman meeting room. The meeting was also available via ZOOM. Commissioners Wollen, McFarland, Hacker, and Wallace were present. Also present were Manager Graffman, Attorney Smith, Captain Sowers and Clerk Conrardy.

Tad Hacker opened the meeting with prayer and the Pledge of Allegiance.

**AGENDA:** Motion made by McFarland, seconded by Hacker approve the August 11, 2022, agenda. Motion declared carried by unanimous vote.

**MINUTES:** Motion made by Wollen, seconded by Wallace approve the July 28, 2022, minutes. Motion declared carried by unanimous vote.

**BILLS PAYABLE:** Motion made by Hacker, seconded by Wallace approve the bills payable in the amount of \$438,492.72. Motion declared carried by unanimous vote.

**PUBLIC COMMENT:** Tad Hacker addressed the Commission that they are putting together similar to last year the Constitution Day to be held on September 17<sup>th</sup>. Some of the Commissioners will be participating in the event. Picnic Table will be needed again.

**PARK BOARD:** Motion made by McFarland, seconded by Hacker appoint Laura Lankford to the park board. Motion declared carried by unanimous vote.

**STANDARD TRAFFIC ORDINANCE:** Ordinance # 2984

AN ORDINANCE REGULATING TRAFFIC WITHING THE CORPORATE LIMITS OF THE CITY OF KINGMAN, KANSAS; INCORPORATING BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES," 49<sup>TH</sup> EDITION PUBLISHED IN 2022; AND REPEALING ORDINANCE NUMBER 2082 was read, considered and upon motion of Hacker, seconded by McFarland it was voted with the following roll call vote.

**UNIFORM PUBLIC OFFENSE ORDINANCE:** Ordinance #2985

AN ORDINANCE REGULATING PUBLIC OFFENSES WITHIN THE CITY LIMITS OF KINGMAN, KANSAS; INCORPORATING BY REFERENCE THE "UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES" 38<sup>TH</sup> EDITION PUBLISHED IN 2022; AND REPEALING ORDINACE NUMBER 2083 was read, considered and upon motion of Hacker, seconded by Wallace it was voted with the following roll call vote.

NAY: None.

A majority of the Commission voted in favor it was given Ordinance #2985 and ordered signed by the Mayor and attested by the City Clerk and ordered to be published in the official newspaper.

**FEES:** Resolution 2022-12

Motion made by Hacker, seconded by Wallace adopt Resolution 2022-12 concerning service, license and

permit fees within the corporate limits and service are of the City of Kingman, Kansas. Motion declared carried by unanimous vote.

**FEMA PROJECT:** Charles Loughman with Wilson & Company was present to discuss the plans for the FEMA Project.

**KINGMAN COUNTY STRONG:** Melinda from the Hospital met with the Commission to discuss what they are planning for Mental Health Awareness on September 24, 2022. Motion made by Harrel, seconded by Hacker close off Sherman from Main to Spruce at 7:00 a.m. to 10:00 a.m. on September 24 so Kingman County Strong can kick off their Walk/Run event. Motion declared carried by unanimous vote.

**FIREWORKS:** Discussion was held on fireworks and the ordinances that go with it. Attorney Smith will change some of the wording and bring it back to the commission.

**SWIMMING POOL:** Gregg Thimesch was present to discuss the problems at the swimming pool. They were losing water under pressure.

Motion made by Wollen, seconded by Wallace refund ticket sales upon request at the City office during open hours for closing the pool early. Motion declared carried by unanimous vote.


**ADMINISTRATIVE REPORT:** Manager Graffman asked the Commission who wants City e-mail addresses. KPP Conference is September 15 & 16<sup>th</sup>. State was in to inspect the CDBG Files, Wilson & Co. had given us a drainage report. August court docket has near 100 cases on it. There is a "No Surprise Act" coming out on Health Insurance. Manager Graffman has been in Kingman 19 years.

**COMMISSION COMMENTS:** Commissioner Wollen talked about how he enjoyed the KPP Conference and asked that other commissioners also attend. Monday there is KDOT meeting at 11:30. Commissioner McFarland cannot go and asked Commissioner Wallace if he could go. Sheahan property has a camper on it. Signs for highway work are still around. Kansas Avenue seal job is holding water down the middle.

There being no further business upon motion of Hacker, seconded by McFarland meeting adjourned at 8:53 p.m. Motion declared carried by unanimous vote.
