CALL TO ORDER: Mayor Harrel called the meeting to order on Thursday April 27, 2023, at 7:00 p.m. at the City of Kingman meeting room. The meeting was also available via ZOOM. Commissioners Wollen, McFarland, Hacker and Wallace were present. Also present were Manager Graffman, Chief Lux, Attorney Smith and Clerk Conrardy.

Commissioner Wollen opened the meeting with prayer and The Pledge of Allegiance.

AGENDA: Motion made by Wollen, seconded by McFarland approve the agenda. Motion declared carried by unanimous vote.

MINUTES: Motion made by Wollen, seconded by Wallace approve the minutes of the April 13, 2023, meeting. Motion declared carried by unanimous vote.

BILLS PAYABLE: Motion made by Hacker, seconded by McFarland approve the bills payable in the amount of \$783,582.27. Motion declared carried by unanimous vote.

ECONOMIC DEVELOPMENT: Leslie went over her report. Leslie announced that Scott Mueller was awarded \$750,000 from the BASE Grant.

CDBG: Resolution 2023-5

Motion made by Hacker, seconded by Wallace adopt a Resolution certifying legal authority to apply for the 2023 Kansas Small Cities Community Development Block Grant Program from the Kansas Department of Commerce and authorizing the Mayor/Commissioner to sign and submit such an application. Motion declared carried by unanimous vote.

Resolution #2023-6

Motion made by Wallace, seconded by Hacker adopt a resolution assuring the Kansas Department of Commerce that funds will be continually provided for the operation and maintenance of improvements to the Park System to be financed with Community Development Block Grant Funds. Motion declared carried by unanimous vote.

AMBULANCE BID: Crestline bid \$288,480, Osage \$310,457.67 and AEV Traumahawk \$346,620.91. After much discussion motion made by Wallace, seconded by Hacker accept the Crestline bid of \$288,480 for an Ambulance. Motion declared carried by unanimous vote.

CHAMBER: Members of the Chamber Board were in to discuss July 4th activities. They would like to close the East Riverside Park down to traffic. There is not an event at the Expo Center that day. Motion made by Hacker, seconded by McFarland close East Riverside Park on July 4th from 7:30 a.m. to 2:30 p.m. and make sure that handicap parking is accommodated. Motion declared carried by unanimous vote.

Eck Electric will be putting up the banners and taking them down for the Chamber.

LAPTOP BIDS: Bids were from Lenovo \$13,755, Huber \$25,920.38, Integris \$22,768.48 Motion made by Wallace, seconded by McFarland approve the bid from Lenovo for \$13,755 for seven laptops for police officers. Motion declared carried by unanimous vote.

HUTTON BILL: There is a balance of \$20,409.89 left on the Hutton Bill. Motion made by Hacker, seconded by Wallace pay the \$20,409.89 to Hutton if the subs are paid in full. Motion declared carried by unanimous vote.

WATTS DRIVE: There were many questions that needed to be answered before we proceeded.

The open meeting will resume in the city commission chambers in 7 minutes. Moton declared carried by unanimous vote.

County will be sealing the Expo Parking Lot. Circle C will be in August or September to do sealing.

COMMISSION COMMENTS: Commissioner Hacker said 308 West D will be down by Wednesday of next week. Removed a lot of concrete today. Talked about the FEMA sidewalk. Lincoln County has adopted MakeMyMove campaign. Thanked Chief Lux and Captain Sowers for the Larry Berry memorial program. Talked about the Truck Parking Lot. Sign for No Parking on the Bank are in. Nolan Freund was named 2022-2023 Dylan Meier Get Busy Livin' Player of the Year Award. Dilapidated House east of the Lumber Yard needs attention. Depot Park was well used for Prom Pictures.
