**ECK FABRICATION CONTRACT:** Motion made by Hacker, seconded by Wallace approve the Contract with Eck Industrial Complex LLC in the amount of \$47,500 with sharing the title insurance and escrow costs. Motion declared carried by unanimous vote.

**PARK BOARD:** The park board and the Axe Attack came to an agreement to have the Park Board Band from 6 to 9 p.m. and the Axe Attack have their band from 9 to 12 midnight.

Motion made by Harrel, seconded by Wallace authorize the closure of B Street west to alley from 6 a.m. to 4 p.m. on September 23<sup>rd</sup>. Motion declared carried by unanimous vote.

Motion made by Harrel, second by Hacker authorize the concert in the Red Barn from 9 to 12 midnight on September 23rd. Motion declared carried by unanimous vote.

**KMU RATE REVIEW:** Motion made by Hacker, seconded by Wollen approve KMU to do an electric & water rate review for \$3,200.00. Motion declared carried by unanimous vote.

**VALVE BID:** Motion made by Hacker, seconded by Wollen approve Core & Main to cut in valves at several locations for an amount of \$54,300.00. Motion declared carried by unanimous vote. The other bid was from Municipal Pipe Services in the amount of \$61,500.

**HIGHWAY LIGHTS BID:** Motion made by Wollen, seconded by Hacker accept the bid from Wesco for 50 lights at \$325. Each. Motion declared carried by unanimous vote. The other bids were from Border State at \$348.91 and Stanion Great Bend for \$357.00 each.

**AIRPORT HANGAR:** Motion made by Hacker, seconded by Wallace table the airport hangar. Motion declared carried by unanimous vote.

CMB: Motion made by Harrel, seconded by Hacker approve the Cereal Malt Beverage Application from Polished Coupe for September 23 from 5:00 p.m. to 11:59 p.m. Motion declared carried by unanimous vote.

**LKM VOTING DELEGATE:** Motion made by Hacker, seconded by Wallace allow Manager Graffman to be the voting member at the LKM Conference. Motion made by declared carried by unanimous vote.

**CONTRACTOR VEHICLE:** Mayor Harrel would like to modify ordinances to have contractors have identification on the sides of their vehicles.

2024 BUDGET: 2024 Budget was discussed.

**ADMINISTRATIVE REPORT:** Applying for grant for cost share for lights at Main & 54. Issues at the High School Sub Station have been resolved. Outage issues earlier this week had to do with some settings. Investment performance has been good. Working on weed notices. Tie Line Bonds will be paid off.

**COMMISSION COMMENTS:** Utility Upgrades are done in Right-of-Way. Leaky Boots on Fire Department. Light at Spruce & 54 is on red, and people turn left. Spruce & G trees need to be trimmed. Tree trimming if getting done. Crews doing an amazing job out in the heat. Distribution throughout the City needs to be studied.
