CALL TO ORDER: Mayor Harrel called the meeting to order on Thursday, March 9, 2023 at 7:00 p.m. at the City of Kingman meeting room. The meeting was also available via ZOOM. Commissioner Wollen, McFarland, Hacker, and Wallace were present. Also present were Manager Graffman, Attorney Smith, Chief Lux and Clerk Conrardy.

AGENDA: Motion made by Wollen, seconded by Wallace approve the agenda for the March 9, 2023, meeting. Motion declared carried by unanimous vote.

MINUTES: Motion made by Hacker, seconded by Wallace approve the minutes of the February 23, 2023, meeting. Motion declared carried by unanimous vote.

BILLS PAYABLE: Motion made by Hacker, seconded by McFarland approve the bills payable for \$204,015.40. Motion declared carried by unanimous vote.

KUDO'S AWARD: Dixon's Hardware was the recipient of the KUDO'S Award this month. The Dixon Family has been a service to this community for years.

BOARD MEMBER: Motion made by Wollen, seconded by McFarland approve Mitzi Bailey to the Economic Development Advisory Board for a 3-year term. Motion declared carried by unanimous vote.

A majority of the Commission voted in favor it was given Ordinance 2104 and ordered signed by the Mayor and attested by the City Clerk and ordered to be published in the official newspaper.

HUTTON BILL: After much discussion motion made by Hacker, seconded by Harrel do not pay the Hutton bill and keep that billing as liquidated damages in the amount of \$21,906.12.

2025 CCLIP PROJECT: The Engineer put together two different projects that could be for the 2025 CCLIP Project. From West City Limits to Ninnescah Street and from Sugar Street to Lincoln Street.

Motion made by Wollen, seconded by Hacker do the Sugar Street to Lincoln Street project. Motion declared carried by unanimous vote.

CITY HALL ROOF: Bids were Burwell Construction \$59,956.57, AP Roofing Option #1 \$50,293.68, Option #2 \$39,647.50, GCI Construction & Roofing, Inc. Option #1 10 year \$28,713.00, 15 year \$38,232.00 or 20 year \$46,146.00, Option #2 \$39,840.00, Option #3 \$35,130.00, Option #4 \$25,506.00.

Motion made by Wallace, seconded by McFarland table the bids until next meeting. Motion carried.

STREET SEALING: BIDS were Southcentral Sealing & Paving \$72,232.17 and Circle C Paving without the fog seal \$72,708.95.

Motion made by Wallace, seconded by Wollen approve Circle C Paving without the fog seal in the amount of \$72,708.95. Motion declared carried by unanimous vote.

AIRPORT MOWING: Motion made by Hacker, seconded by McFarland approve Sowers Handyman bid to mow the airport in the amount of \$19,215.00 from April to October. Motion declared carried by unanimous vote.

ADMINISTRATION: Working on the CUSI Billing changes. Fire Department did train at 308 W D. Decals are being made at Factory 233. Convention & Tourism is giving a grant to the Youth Rodeo. Need to watch SB 248 and HB 2447. Consensus of the commission gave Manager Graffman approval to address these bills with the League.
