AN ORDINANCE AMENDING SECTION 12-801 OF THE CODE OF THE CITY OF KINGMAN CONCERNING KINGMAN ECONOMIC DEVELOPMENT ADVISORY COMMITTEE; FORMATION.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF KINGMAN, KANSAS:

Section 1. Section 12-801 shall be amended to read as follows:


“12-801. There is established a Kingman Economic Development Advisory Committee of this city, which will consist of five members. The governing body of the city shall select the five members, each holding a three-year term. In the first round of appointments, two of the members selected by the city shall have a two-year term. Vacancies shall be filled by appointment for the unexpired term.”
