## AN ORDINANCE ANNEXING LAND TO THE CITY OF KINGMAN, KANSAS.

WHEREAS, the following described land adjoins the City of Kingman, Kansas;

WHEREAS, a written consent for annexation of the following described land, signed by all of the owners thereof, has been filed with the City of Kingman, Kansas pursuant to K.S.A. 12-520, as amended; and
